**Description****Product description:**

The visually detectable operating parts are made from a EU10/2011 and FDA conform blue coloured plastic granulate. The colour ensures an optically discernible contrast between the operating parts and other media and materials. This means that in sensitive production sectors, e.g. foodstuff processing, plastic fragments of visually detectable operating parts can be identified and the risk of production downtimes or complaints are significantly reduced.

Material:

Thermoplastic (fibreglass reinforced polyamide), visually detectable, EU10/2011 and FDA conform.
Steel parts stainless steel 1.4404.

Version:

Thermoplastic ultra marine RAL 5002.
Steel parts bright stainless steel.

Note:

Palm grips with projecting steel bush and internal thread are highly suitable for cross pinning.

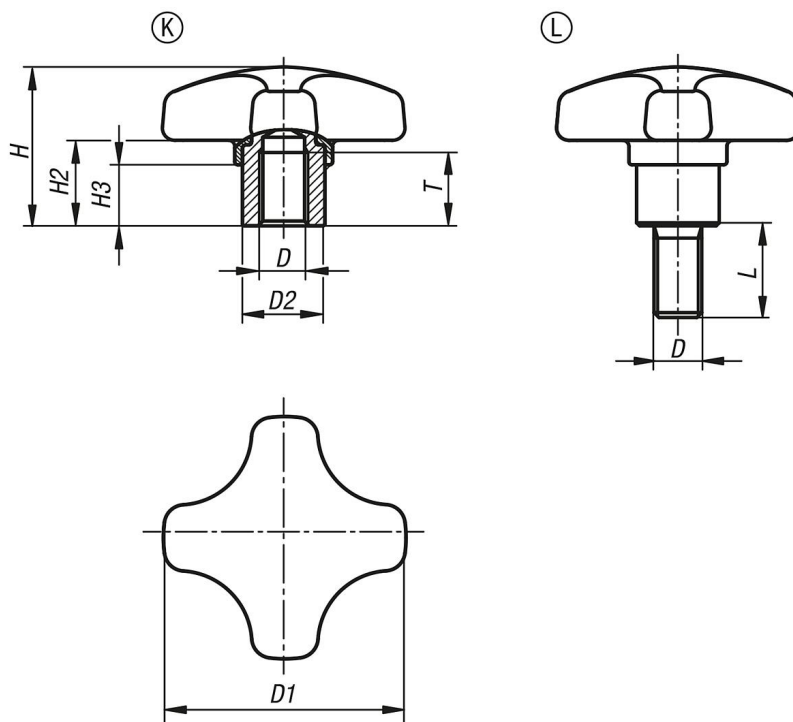
